 The passage of the National Defense Authorization Act provides for an additional 0.5% increase in the base pay Cost of Living Adjustment, retroactive to 1 Jan 2008. The total 2008 increase is 3.5%. This February payment includes the January adjustment. As a part of the transition to a new payroll system, the Earnings Statement format has changed and will be used until it is replaced by self service access to this information. To assist with understanding this statement, an e-Bulletin will be sent by OCCO. Updates on the status of the new payroll system will be similarly provided.
